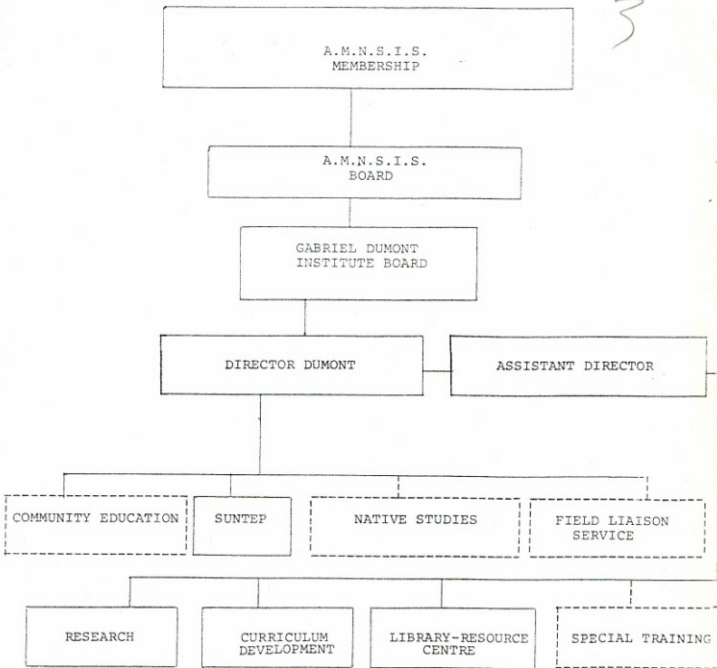

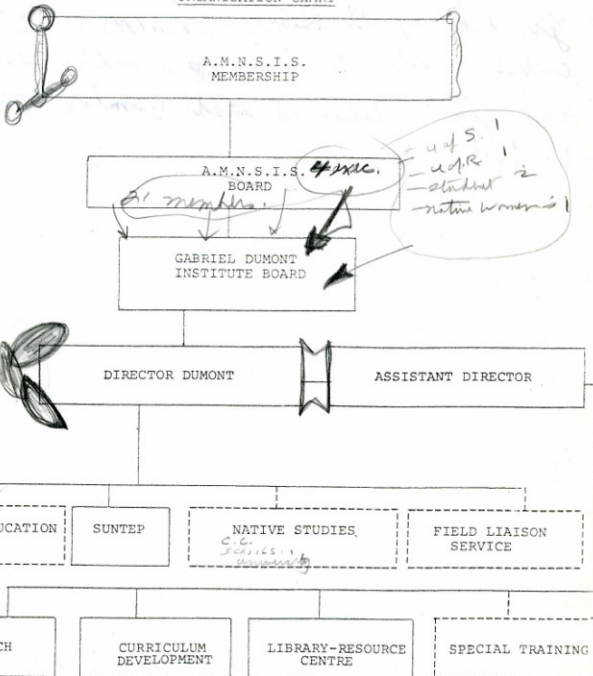
ORGANIZATION CHART

OBJECTIVES:

To carry on historical, cultural and social research;

To develop and offer courses to strengthen Native cultural awareness dealing with both the historical and current cultural situation of Native people;

To promote, develop and implement programs designed to improve cross-cultural relationships and increase cross cultural understanding and awareness;

To develop unique Native education programs and resources for use in both Native and Non-Native education programs;

To establish a Library-Resource Centre where such resource materials and aides are available for use and distribution;

To participate in the development and the implementation of a Native Studies Program at the provincial universities;

To promote the unique educational needs of Native young people by implementing special programs such as the Native Teacher Education Program and by encouraging and assisting Native students to pursue a variety of careers and professional opportunities;

To provide special programs of a remedial nature to assist Native students to upgrade their basic life and job skills;

To promote and assist in the planning of community education programs to be delivered to local Native communities; and,

To provide special training programs for the staff of Native organizations, private Native entrepreneurs and others willing to train and employ local people.

NATIVE ALCOHOL COUNCIL
NOVEMBER 6, 1980

The Native Alcohol Council (NAC) is a rehabilitation program established in 1968 by the Association of Metis and Non-Status Indians of Saskatchewan (AMNSIS) to assist our people when seeking treatment for alcoholism and drug abuse.

BLOCK FUNDING:

NAC is funded by the Saskatchewan Alcoholism Commission, the \$440,780.00 received effective April 1, 1980 is financially operating the Prince Albert, Saskatoon, and Regina NAC Social Adjustment Centres.

The funding is a step forward for NAC, ridding many of the hassles with the Department of Social Services.

PROGRAMS:

- (1) Prince Albert Out-Patient Service Centre: The Prince Albert Service Centre is a valuable and desirable program offered by NAC to assist the people with follow-up and continuing care services when being released from in-patient treatment centres. Objectives of the programs are to assist the client to re-adjust his or her life of sobriety. Objectives such as helping clients in areas of finding adequate housing, legal aid pertaining to their problems, individual counselling, couple counselling, assisting the non-alcoholic spouse, employment - if unskilled, refer them to training centres and to act as an informational centre.

- (2) Regina Crisis Intervention and Drop-In Centre: Regina's native population is constantly on the increase, this in turn increases the need for a crisis intervention, referral and informational service centre for native families before permanent alcoholism and drug abuse damage takes its toll. Two trained staff will be on call 24 hours a day to provide expertise counselling to the clients when a crisis situation arises, their services will be available to other agencies to assist them in giving meaningful direction.

The Native Alcohol Council treated approximately 432 patients in the 1979 - 80 fiscal year. Many of these patients were referred to the centres by social workers, court workers, police, doctors, family workers, and our own experienced fieldworkers.

NAC knows that this is only a mere fraction of our people who seriously need help, but many tend not to seek it. We only hope that patients who have been rehabilitated can set examples in their communities.

PROVINCIAL METIS SOCIETY HOUSING ASSOCIATION

Programs offered by the Provincial Metis Society Housing Association are briefly described and outlined below:

EMERGENCY REPAIR PROGRAM (E.R.P.):

This program provides emergency repairs to homes which require specific action to ensure health and safety assistance is provided on a short-term basis, usually pending replacement housing facilities.

It is available to those applicants whose incomes are not sufficient to finance their own renovations.

RESIDENTIAL REHABILITATION PROGRAM (R.R.A.P.):

This program is offered to people wishing to make essential repairs to their homes, which they must own and occupy. You must have an adjusted family income of \$12,000 per year in order to qualify for a loan to begin the repairs to your home.

RURAL AND NATIVE HOUSING PROGRAM (R.N.H.):

This program provides dwelling units available to towns, villages, hamlets, and rural municipalities of 2,500 people or less.

Requirements of the applicant are that you must be residing with a spouse with or without dependents or a single parent with one or more dependents. You must have a satisfactory credit rating and a gross family income not exceeding \$15,000 per annum to qualify for a mortgage, which is subsidized.
