BETWEEN: HER MAJESTY THE QUEEN in the right of the Province of Saskatchewan herein represented by the Minister of Education (hereinafter called the "Minister")

OF THE FIRST PART

- and -

ASSOCIATION OF METIS AND NON-STATUS INDIANS OF SASKATCHEWAN, Southeast Area, in the Province of Saskatchewan (hereinafter called the "Contractor")

OF THE SECOND PART

WHEREAS the Department is desirous of researching certain questions with respect to the history of the Lebret Colony Farm of the Province of Saskatchewan;

BE IT RESOLVED that the parties enter into an agreement under the following terms and conditions:

1. The Service to be Provided:

- (a) The Contractor shall research and report on the history, operation and legal background of the Lebret Colony Farm, of the Province of Saskatchewan, during the period 1945 to the present. In particular, the Contractor shall:
  - (i) Carry out archival research with respect to the history and legalities of the Lebret Colony Farm;
  - (ii) Interview relevant church officials and research relevant church documents with respect to the history and legalities of the Lebret Colony Farm;
  - (iii) Hold local hearings to document through oral testimony, the history, operation and legalities of the Lebret Colony Farm;
  - (iv) Document all legal and moral commitments with respect to the Lebret Colony Farm;
  - (v) Compile a history of persons who worked at, or were otherwise directly associated with, the Lebret Colony Farm;
  - (vi) Compile a general history of the Lebret Colony Farm.
- (b) The Contractor agrees to submit a final report on sub-section 1.(a) to the Department by March 31, 1981.

2. Term of Agreement:

This agreement shall be in force from the fifteenth day of November, 1980 to the thirty-first day of March, 1981 and may be extended by mutual agreement of the parties by an exchange of letters of agreement to extend.

3. Agreed Payment:

- (a) The Department agrees to pay the Contractor a sum not exceeding Fifteen Thousand Dollars (\$15,000) for all services rendered pursuant to this agreement;

- (b) Payment specified in subsection 3(a) above, shall be paid as follows:
- (i) One payment of \$10,000 on the first day of December 1980;
  - (ii) One payment of \$4,000 on the first day of January 1981;
  - (iii) One payment of \$1,000 upon receipt by the Department of the final report.

4. Special Conditions:

- (a) For cause or failure to uphold the terms and conditions of this agreement, either party may give written notice to the other to terminate this agreement and said agreement shall be wholly terminated;
- (b) The Contractor agrees to indemnify the Department harmless from any and all actions, claims, demands, and remedies, which anyone may have against the Department arising out of proved negligence of the Contractor in the performance of duties under this agreement;
- (c) The Contractor shall not assign or transfer this agreement to any other party without written consent from the Department;
- (d) The Department hereby waives any copyright interest it may have in the research material and shall have no claim against the Contractor for remuneration or otherwise for any future use made by the Contractor of the research material.

WHEREAS the Department is desirous of researching certain

BE IT RESOLVED that the parties enter into an agreement  
under the following terms and conditions:

1. The Service to be Provided:

- (a) The Contractor shall undertake an ethno-historical research study of the Lebret Colony Farm of the Province of Saskatchewan, during the period from approximately the year 1945 to the present;
- (b) The ethno-historical research study mentioned in subsection 1.(a) above shall include economic, social, cultural, educational, political and/or any other aspects of the history of the Lebret Colony Farm deemed important by the Contractor and may include a history of persons who worked at, or were otherwise associated with, the Lebret Colony Farm.
- (c) The ethno-historical research study mentioned in subsection 1.(a) and (b) above may include both oral testimony and documentary and archival research as required to complete said research study;
- (d) The Contractor agrees to submit a final report on subsection 1.(a) to the Department by March 31, 1981.

2. Term of Agreement:

This agreement shall be in force from the fifteenth day of November, 1980 to the thirty-first day of March, 1981 and may be extended by mutual agreement of the parties by an exchange of letters of agreement to extend.

3. Agreed Payment:

- (a) The Department agrees to pay the Contractor a sum not exceeding Fifteen Thousand Dollars (\$15,000) for all services rendered pursuant to this agreement;
- (b) Payment specified in subsection 3.(a) above, shall be paid as follows:
  - (i) One payment of \$12,000 on the first day of November, 1980;
  - (ii) One payment of \$4,000 on the first day of January, 1981;
  - (iii) One payment of \$1,000 upon receipt by the Department of the final report.

Special Conditions:




